Registered pursuant to application no 914 made on 31st December 1969 by Ramblers Association, 124 Finchley Road, London NW3. (Registration Provisional)
002	07-Sep-1970	REGISTRATION AMENDMENT - THE PART OF THE LAND COMPRISED IN THIS REGISTER UNIT HATCHED BLACK IS REMOVED FROM THE REGISTER PURSUANT TO A RESOLUTION OF THE PEMBROKESHIRE COUNTY COUNCIL MADE ON 28TH JULY 1970 FOLLOWING OBJECTIONS BY THAT AUTHORITY ON 21ST JULY 1970 WITH THE AGREEMENT OF THE APPLCANT, THE RAMBLERS ASSOCIATION OF 124 FINCHLEY ROAD, LONDON NW3.
003	15-Jan-1986	THE REGISTRATION AT ENTRY NO 1 ABOVE WHICH WAS DISPUTED BECAME FINAL ON THE 11TH NOVEMBER 1985 FOLLOWING A REGULATION 31 AGREEMENT.
004	18-Nov-2008	Registration amendment: Two parcels of land labelled A1 & A2 adjacent to Town Moor in the urban district of Narberth as marked with a green verge line inside the boundary on Sheet No.27 of the Supplementary Map of the Register Map and distinguished by the number of this register unit. A/1 - 1338 square metres of grassed land interspersed with trees, which slope very gently in a southerly direction and stops at the start of the wooded area between the rear boundaries of No.'s 29 & 30 Garfield Gardens. A/2 - 960.8 square metres of open woodland which has a very gentle incline in a south westerly direction. Registered pursuant to an application dated 25 January 2005 made by Pembrokeshire County Council, County Hall, Haverfordwest SA61 1TP.
005	18-Nov-2008	The land comprised in the registration at Entry No.4 above became Town/Village Green on 24 October 2008, in substitution for the land removed from the register at Entry No.6 below by virtue of an Order of Exchange from the Welsh Assembly Government dated 24 October 2008 under section 147 of the Inclosure Act 1845 and is subject to the same rights, which were immediately before the said date exercisable over the said removed land.
006	18-Nov-2008	Registration amendment: Part of the land comprised in this register unit and numbered B/1 (hatched purple on the supplementary map) ceased to be Town/Village green on 24 October 2008 and is therefore removed from the Register of Town and Village Greens (1,317 square metres)
